

### T&C of "Setanta + Netflix' on Magti".

- These T&Cs represent the terms of use of the "Setanta + Netflix' on Magti" offer (hereinafter - "Offer"). Before activating the "Offer", please read these terms carefully and activate only if you agree with all the provisions below;
- To activate the "Offer", you must be a customer of "Magticom" fiber optic and/or IP television service;
- If you use "Magticom's" additional TV package "Setanta", it will be canceled once you activate the "Offer". If desired, it will have to be reactivated if the "Offer" is canceled;
- The 30-day fee for using the "Offer" will be charged at once during the activation;
- After the subscription every 30 days a 30-day fee for using the offer will be charged automatically;
- You may cancel the "Offer" at any time, but it will come into effect at the next charging date;
- If you make a request to cancel the "Offer", you may revoke it at any time before the cancellation becomes effective;
- Sharing your email and mobile number with "Netflix" and "Setanta Sports" is required to activate the "Offer". We remind you that "Magticom" processes your personal data in accordance with "Magticom" [privacy policy](#), which is available on the website. The privacy policy of "Netflix" / "Setanta Sports" can be viewed on the websites of "Netflix" and "Setanta Sports";
- The Setanta Sports service is provided to you by Eurasian Broadcasting Enterprise Limited under the Setanta Sports Terms of Use, which will be provided to you separately.
- The Netflix service is provided to you by Netflix International B.V. under the Netflix Terms of Use, which will be provided to you separately.
- In order to enjoy the "Netflix" service and "Setanta Sports" service as part of the "Offer", you will need to complete the "Netflix" and "Setanta Sports" activation processes. You will receive instructions via email or text message.
- If you have an existing "Netflix" service account, you can link it to your "Offer" when you complete the "Netflix" activation process. You will continue to be charged separately for any existing "Netflix" service account until you link that account to your "Offer". For any queries regarding your billing with "Netflix" for your existing "Netflix" service account please contact "Netflix" directly.
- If you have an existing "Setanta Sports" service account, you can link it to your "Offer" when you complete the "Setanta Sports" activation process. You will continue to be charged separately for any existing "Setanta Sports" service account until you link that account to your "Offer". For any queries regarding your billing with "Setanta Sports" for your existing "Setanta Sports" service account please contact "Setanta Sports" directly.
- If you are already subscribed to "Netflix" and/or "Setanta Sports", you can still activate the "Offer". If you would like a refund for your existing "Netflix" and/or "Setanta Sports" subscription, you must contact "Netflix" and/or "Setanta Sports" individually. Refund is subject to the terms/policies established by "Netflix" / "Setanta Sports";
- If you downgrade the "Netflix" plan within "Offer", a refund of the unused amount will be deposited to your fiber optic and/or IP TV subscription account;
- Other "Netflix" plans ("Standard" and "Premium") can be activated after activating the "Offer" ("Setanta + Netflix' from Magti").
- The "Netflix" plan can be changed by user anytime, but the updated plan will come into effect from the next day. Once the change of the plan comes into effect you will be charged/refunded accordingly;
- In the case of upgrading the "Netflix" plan (activating a more expensive plan) and then downgrading it (switching to a less expensive plan) during the same calendar day, the daily subscription fee of the higher value "Netflix" plan will be charged;

- Cancellation of "Netflix" as part of your "Offer" will not automatically cancel any pre-existing linked "Netflix" service account and "Netflix" will automatically resume charging any existing method of payment of yours that they have on file. - Cancellation of "Setanta Sports" as part of your "Offer" will not automatically cancel any pre-existing linked "Setanta Sports" service account and "Setanta Sports" will automatically resume charging any existing method of payment of yours that they have on file. If you wish to review the details of your Setanta Sports membership please visit the 'Account' pages on the Setanta Sports website;
- You can use the "Setanta Sports" service and "Netflix" service with any device of your choice that is compatible with the Setanta Sports Terms of Use and Netflix Terms of Use. You must be connected to the Internet to receive the services;
- The "Offer" can be activated only from the territory of Georgia;
- The territory from which it is possible to use the services of "Setanta Sports" and "Netflix" is determined in Setanta Sports Terms of Use and Netflix Terms of Use respectively;
- The "Offer" can be activated only once per user;
